7. Scenario Planning Exercise (7:20 – 9:30)

Working in small groups, Committee members will engage in the Scenario Planning exercise. Each working group will be provided with a recorder from City staff or the Technical Team and a set of issues or questions to be addressed as part of their report-out on Friday. Each working group can work through the exercise in a manner that is comfortable to them. The portfolios prepared by the working groups will be analyzed by the Technical Team and by the Committee using the MCDS model without further changes by the Committee.

The basic steps of the scenario planning exercise involve Committee members, working in assigned small groups to:

- review the scenario to which they have been assigned,
- develop and agree on a maximum of two portfolios to respond to each scenario, and
- prepare materials to report out about their work at the meeting on Friday, March 20th.

The scenario planning exercise will also give Committee members a chance to practice using a variety of collaboration problem solving skills and tools in the process of developing and agreeing to portfolios of measures to respond to the scenarios. Skills useful in this effort include:

- interest based bargaining, and
- communication and dialogue skills (e.g., the ladder of inference).

Desired Outcomes:

- Working groups will need to develop:
 - One (or at the most two) portfolios that respond to the assigned scenario and that will be evaluated for consideration at the April/May meeting;
 - Materials for use in the report-out for the working group at the Friday session.

12. Evaluation Criteria and MCDS Evaluation Next Steps (3:45 – 4:45)

The portfolios created in the scenario planning exercise will be analyzed and evaluated in a variety of ways between the March and April/May meetings. One of those evaluation efforts will involve the Committee's use of a Multi-Criteria Decision Support (MCDS) model to evaluate and give feedback on the portfolios.

Significant work has been done on clarifying, and further developing the MCDS model criteria that were used in the Committee's evaluation of range of alternatives in early December. Based on the Committee's earlier experience with the MCDS model, to make the most out of the use of the MCDS tool, Committee members need a common understanding of, and agreement about, the evaluation criteria, and what is being measured by the criteria and how it is being measured (the scale).

During this agenda item, the Committee will review and reach agreement on the set of evaluation criteria they will use in the MCDS model for the evaluation of portfolios.

Desired Outcomes:

- Committee understanding of, and agreement about:
 - The definition of each criterion
 - The scale used for each criterion
 - The applicability of each criterion to alternatives, portfolios of measures, or both
 - o The hierarchy (tiers) of criteria/subcriteria to be used in the model, if any
- Agreement on any direction from the Committee to the technical team about the MCDS modeling effort that will help the Committee most effectively utilize this tool in its deliberations.
