SESSION ONE

<u>Call to Order</u> - Facilitator Nicholas Dewar called the meeting to order at 5:02 P.M.

Roll Call: Committee Members present: Engfer, Baskin, Holt, Jacobson, Keutmann, Longinotti, Mansergh, Mesiti-Miller, Beckmann, Slatter, Stanojevic, Stearns & Pepping. Committee Member absent: Rotkin.

Welcome to Public and Public Comment

Facilitator Nicholas Dewar welcomed the public. Seven members of the public spoke on matters relating to expediting the evaluation and implementation of certain alternatives, the size of the demand/supply gap, negotiating water transfers with other agencies, off-stream storage, concerns about water reuse, recommending water transfers from Soquel Creek Water District to the Graham Hill Water Treatment Plant and the grouping of Consolidated Alternatives into Portfolios will make rating of those "CAs" less effective.

Committee Member Updates

Three members of the Committee spoke on matters relating to Desal Alternatives considering the benefits of water pricing and the PAYS system, the Sierra Club discussing the progress of the Committee at its meetings, the Water Commission discussing the significance of integrating sewer service and water fees to strengthen the economic signal of higher water prices, and the Santa Cruz Chamber of Commerce and the Santa Cruz County Business Council meeting with Desal Alternatives to discuss the work of the Committee.

Agenda Review

Facilitator Nicholas Dewar led Committee Members in a review of the agenda for the WSAC's eleventh meeting. By consensus, the Committee agreed to insert questions about various aspects of the technical work into the agenda of the second session on Friday afternoon and to accept the agenda as amended.

Consolidated Alternatives

Technical Team Member Bill Faisst and WSAC Consultant Bob Raucher led Committee Members in a discussion of the Consolidated Alternatives and the Technical Sheets prepared for each of them.
